Executive summary

City of Newcastle (CN) carried out community engagement to build awareness about improvements proposed under the Wallsend PDP, and to obtain further community input on developing unifying themes and design character for Wallsend, the design of future construction stages and the prioritisation of future construction stages.

This report highlights the findings from the engagement period, which will help CN understand community views around project staging, support level towards a suite of proposed ideas and the progression from draft concepts through to detailed designs and implementation.

These insights were collected from 28 July and 28 August 2020 via an online survey. Online engagement was the main method due to the restrictions and concerns in relation to COVID-19 social distancing.

The survey was completed by 407 people from across the Newcastle LGA. The demographics captured show most respondents were females, aged 25-54 and lived in Wallsend or closely surrounded areas. Other than living in Wallsend (52%), respondents indicated their personal connection to the area was mainly for shopping (81%) and using Wallsend Library (30%).

Key engagement findings

Preferred design styles

- Design style perceived as best suiting the local area:
 - o traditional urban centre style (emphasis on industrial/built heritage) (51%)
 - o large village centre style (unique, local, quirky, community feel) (31%)
 - o modern urban centre (contemporary CBD style) (18%).
- Style of landscaping perceived as best suiting the local area:
 - biodiversity planting (45%)
 - o colourful flowers and foliage (40%)
 - o manicured formal civic style (15%).



Prioritisation for future staged works

The top three areas identified as the highest priority areas were:

- 1. Main commercial area
- 2. Heritage area (near Rotunda Park, Post Office and Courthouse)
- 3. Wallsend Village Mall area (Wallsend Village street frontages and Bunn Street)

Project areas

The following received over 90% of respondents saying these were good ideas:

Laneway Commercial (Council Street) area

Exploring the creation of a direct pedestrian link between Nelson Street and Wallsend
 Village Mall (92%)

Heritage Area near the Rotunda

o New tree plantings and landscaping (to cool the area in summer) (91%)

Ironbark Creek Channel

Bridge upgrades to accommodate future widening of Hunter Water's channel (90%)

Cowper Street West (including northern end of Wallsend Park)

o Upgrading Ironbark Creek channel within Wallsend Park to increase flood capacity (91%).

Completed works improvement

Over two thirds of respondents said they considered these works as being an improvement to the town centre:

- Upgrade of Tyrrell Street Bridge to let more flood water through (73%)
- Providing larger disabled parking spaces outside Wallsend library (69%)
- Relocating and upgrading the bus stop from outside the Merindah childcare centre to outside
 Wallsend Library (68%).

1. Introduction

City of Newcastle's (CN's) vision for Wallsend town centre is to revitalise the public domain to create a thriving, safe, functional, comfortable, unique and attractive town centre that people love, and is fit to meet the community's needs now and into the future.

In May 2015 Newcastle's elected Council resolved to develop a Town Centre Master Plan for Wallsend. This became part of the Local Centres Public Domain Renewal Program, which started in 2016.

The purpose of the Wallsend Public Domain Plan (PDP) is to revitalise and activate the precinct over 10 years. The plan also aims to improve traffic and mitigate flooding. The proposed improvements will be delivered in about 14 construction stages. Stages 1 and 2 have been completed and stage 3 is at detail design stage. Due to the long-term nature of the project, ongoing engagement with the community is required to ensure their needs and expectations are taken into consideration. Previous community consultation was carried out in November 2016 to inform the Wallsend PDP. The draft plan was exhibited to the public from 3-31 May 2017.

The current phase of engagement took place between 28 July and 28 August 2020. This report outlines the key communication methods used to promote the engagement activities and presents the key findings from the data collected.

2. Engagement activities

Engagement for the Wallsend Town Centre was carried out online through a survey and a Social Pinpoint 'Ask a Planner' mapping tool.

Objectives

The aim of the engagement was to come back to the community to talk about the improvements proposed under the Wallsend PDP and to get further community input on:

- · unifying themes and design character for Wallsend
- design of future construction stages
- prioritisation of future construction stages
- ideas around placemaking within the town centre.




Figure 1 Wallsend map identifying key sections

The project area was broken down into sections, see Figure 1.

4. Online survey methodology

Questionnaire

There was a total of 4 demographic questions and 13 quantitative questions. An additional 12 openended 'other' fields were incorporated within the survey to allow the respondents to expand upon specific quantitative questions. Two questions pertaining to signing up for future engagement were also asked.

The survey questions can be found in Appendix 2: Survey.


Data collection

The survey was open from 28 July to 28 August 2020.

The survey was promoted through social, digital and traditional media channels and was available to all community members via CN's website. The promotional channels and overall reach are outlined in Appendix 1: Communications and Promotion. Members of the City's community panel (Newcastle Voice) were also sent email invitations to take part in the survey.

Respondents


The survey was completed by 407 people from across the local government area (LGA). The demographics captured show most respondents were females, aged 25-54, that live in Wallsend and closely surrounding areas.



More than half of all survey respondents fell between the age group of 25 – 54yrs, followed by respondents who are 55 or older (30%).

More than half of the responses received came from women (66%), followed by men (34%).

A total of 390 survey respondents identified themselves as living within Newcastle LGA. The majority of respondents (n=197) lived in Wallsend itself (48%) with an additional 33 % living in surrounding suburbs.

5. Online survey findings

The following pages outline both the quantitative and qualitative findings from the online survey. All qualitative comments can be found in Appendices.

The survey began by determining respondents' connection to Wallsend. Other than living in Wallsend (52%), connection to the area was shopping (81%) and Wallsend Library users (30%).

Connection to Wallsend




Figure 4: Connection to Wallsend

Future engagement

Respondents were asked to indicate if they were interested in CN's Façade Improvement Scheme¹ and could provide their email address indicating agreement to be contacted by CN at a future date about the improvement scheme. There were 13 expressions of interest.

Respondents were also asked to again provide an email if they were interested in being contacted at a future date for a walking tour in Wallsend. Over 150 individuals provided their contact email

¹* A Facade Improvement Scheme grant is a grant which encourages property owners and tenants to make improvements to facades e.g. cleaning, painting, repairs and landscaping for private building frontages.



illustrating that just over 1 in 5 survey respondents had an interest in CN organising a tour. From this group of respondents 75 lived in Wallsend and 63% were female.



Design style


Respondents were given three design styles and asked which best suits the local area. The options were:

- traditional urban centre with emphasis on industrial/built heritage;
- modern urban centre (contemporary CBD style);
- large village centre with a unique, local, quirky, community feel.



Images were provided to assist respondents with examples of each style (see Figure 5)

Half the respondents selected the traditional urban centre style (51%), followed by the large village centre style (31%) with modern urban centre receiving the lowest endorsement (18%).

Landscaping style

Respondents were asked to select which style of landscape best suits the local area. The options were:

- manicured formal civic style;
- biodiversity planting;
- colourful flowers and foliage.





Figure 7: Image used in survey to show examples of landscaping styles





The landscaping results were close for two of the three options; Biodiversity planting (45%) and colourful flowers and foliage (40%). The manicured formal civic style was the least popular choice at 15 %.

Prioritisation of future construction stages

Respondents were asked to identify the project areas that are of highest priority for construction. This helps CN understand where to focus their efforts. The main commercial area was identified as the highest priority area, followed by the heritage area and the Village Mall area. See table 3 below for further details.

Project Areas

The following 12 questions look at individual areas of Wallsend, results are presented in the section that follows. There was also an opportunity to suggest other ideas they may have.

The topics below show overall themes for the whole project area. Please note the small sample sizes.

- ➤ **Greenspace** More greenery, trees, plantings not only for beautification but also for community building by introducing a community garden (potentially edible), more shade from the heat and planting of natives
- ➤ Heritage and Indigenous heritage maintaining Wallsend's rich history including tram and rail, military monuments (in particular Indigenous soldiers, women and non-human war heroes) and including Indigenous Heritage (in collaboration with elders) and being inclusive of multicultural heritage
- > Road safety Lack of crossings, pedestrian safety and cyclist safety, poor road visibility
- > Traffic calming required to assist with speeding and congestion
- ➤ Maintenance general cleaning of the areas including, removal of rubbish, weeds, fixing cracked footpaths and fences.
- ➤ **Lighting** more lighting to be installed was mentioned for all areas
- > Security improvements and crime deterrence Improving lighting, streetscape to assist with pride of the area and implement CCTV
- Cycling shared pathways being an issue for pedestrians feeling lack of respect, potentially shared pathway etiquette education, make Wallsend more cycle friendly and improve connectivity.



Centrelink, Pioneer Hall and Wallsend Baptist Church area

There was strong agreement with one of the ideas presented to improve the Centrelink, Pioneer Hall and Wallsend Baptist church area with 87% stating they agree with providing missing sections of the pedestrian and cycle path.

The second idea put forth was the removal of the pedestrian bridge/cycleway and replace with a new shared path on Cowper Street to address crime concerns. Of all respondents, 65% agreed this was a good idea.




Figure 8 Ideas for Centrelink, Pioneer Hall and Wallsend Baptist Church area

Respondents were also asked if they had any other ideas for this area.

- > Lighting (13% n=12) mentions of poor lighting and the need for it to be improved in this area.
- > Greenspace (12% n=11) more greenery, plantings and trees and general greening of the area.

Verbatims sample:

Lighting! There's so much little street lighting

More green areas - but leave with good visibility for safety



Nelson Street and Cowper Street Central Area

This area was ranked as highest priority. Respondents had reasonably strong responses for most of the ideas in this part of the town centre.

Providing new pedestrian and cyclist crossing at the traffic lights was the most supported idea (82%), followed by footpath widening for outdoor trading (80%), and kerb extensions to assist with pedestrians crossing (76%).

Respondents also commented on being supportive of the outdoor trading, provided pedestrians had adequate room.

The removal of the shade shelter was not overly supported by respondents with 45 % stating they didn't think the removal was a good idea, while 28 % selected that they didn't know. In the verbatims there were questions asked surrounding if it is being removed is there another one being installed elsewhere.

Respondents were also asked if they had any other ideas for this area.

- ➤ Road safety (17% n=13) pedestrian crossings and road markings.
- > Traffic (16% n=12) reduction in traffic, poor visibility and lower speed limits.
- ➤ Greenspace (17%n=13) plantings, street trees and mention of natives to create a village feel.






Figure 9 Ideas for Nelson Street and Cowper Street Central

Verbatims sample:

Nelson street needs much more and clearer line markings as well as the proposed pedestrian crossings.

Would be lovely if we could see more street trees or plantings. The area really needs some additional greenery to help give a village feel.

Crossing Cowper St is really hard. It would be good to reduce traffic speeds on this road to make it feel less like a high speed through route.



Laneway Commercial (Council Street)

Most respondents agreed that CN should explore a direct pedestrian link between Nelson Street and Wallsend Village Mall (92%). The next most supported idea for the area was kerb extensions at the Tyrrell Street intersection to improve sightlines for vehicles (76%), followed by footpath treatment at Tyrrell Street intersection (71%).




Figure 10 Ideas for Laneway Commercial (Council Street) area

Respondents were also asked if they had any other ideas for this area. Themes that came through were parking, maintenance and traffic. Maintenance refers to tidying up of the area, especially the derelict buildings and squash building. Cleaning of gutters and maintenance to footbridge.

There were concerns about lack of parking and generally asking for no paid parking to assist local businesses.

Verbatims sample:

Traffic and parking along our glorified laneway are awful. Sunday is the only day without issues.

We don't want less shop space. Don't want paid parking as this will not help. It will be like Newcastle. It will turn away people who can park in larger shopping centres with no parking fee.



We don't want less parking as we need more parking everywhere as it is a nightmare now.

Tidy it up. Messy, old and ugly at the moment.

Laneway Commercial (Harris Street and William Street Area)

Half of the respondents agreed there should be a roundabout at the intersection of Harris, Charles and William streets.




Figure 11 Ideas for Laneway Commercial (Harris Street and William Street) area

Respondents were asked if they had any other ideas Laneway Commercial Area (Harris Street and William streets).

Verbatims sample:

Smart lighting, to feel safer in that area of a night-time.

Improvements to kerbs when accessing the corner of Federal Park, I often have a pram and find it difficult to manoeuvre paths and kerbs to access the park. I love the Wallsend street art piece in this area (the train), it would be nice to see Wallsend history illustrated in this way

Signage to advise of the best way to access federal park and directions to other facilities like the library and the shopping mall.



Diggers Area (RSL and car parking frontages)




Figure 12 Ideas for Diggers Area

Respondents were asked if there was anything else they would like to see in this area. Armed forces, streetscape and Indigenous culture were the main themes that arose.

- Armed forces (23% n=10) some respondents suggested there is already a heavy focus on the armed forces in Wallsend and mentioned indigenous soldiers and multicultural.
- > Streetscape (19% n=8) said make the area look nicer, diggers frontage, plantings , paint rotunda.
- Indigenous culture (14% n=6) mentions of representing indigenous culture with native plantings and memorials or sculpture.

Verbatims sample:

More comfortable seating in the rotunda and the toilet block painted.

More trees. Trees in the carpark to provide shade for cars and shade for those walking from the carpark or closest public transport stop into the Diggers. Elderly patrons must find that pretty tough on a 40 degree day, with the summer heat reflecting off the bitumen.

Difficult to comment on generalist 'Streetscape elements that honour the armed services' without seeing the detail of the proposal. Wallsend already is very war-heavy (flags everywhere, TPI house, Diggers, cenotaph, etc), which needs to be balanced with a view to the future and attracting new businesses and new, younger residents. If the streetscape elements are simple, tasteful and not overbearing, then this may be worthwhile.



Heritage Area near the Rotunda

New tree plantings and landscaping that cools the area and streetscape elements that interpret Wallsend's heritage received the highest levels of support (91% and 90% respectively). These themes came through quite strongly in the open-ended question.




Figure 13 Ideas for heritage area near the Rotunda

There were comments around the removal of the toilets as shown in the graph above, respondents do not support the removal of the toilet amenities, instead they wish for them to be upgraded. With mentions of them needing better signage and being required for visitors/tourists, those exercising in the area and homeless.

Verbatims sample:

Public toilets are required in the street. The nicer you make them and maintain them constantly will discourage unsavoury types for hanging around and damaging property.

I would Aboriginal heritage and culture is also considered and showcased.

Also nice would be community gardens with edible vegetables, herbs, flowers, bush Tucker.

More comfortable seating in the rotunda.



Heritage Area near TPI House

Designing elements that interpret Wallsend's Heritage had the highest levels of agreement for the Heritage Area (84%), followed by pedestrian accessibility (78%).




Figure 14 Ideas for Heritage area near TPI house

Respondents were asked in an open-ended question if they had any other ideas. Themes that arose were heritage value, pedestrian safety and rail and tram history.

- ➤ Heritage (18% n=7) safety for pedestrians, crossings, shared paths and connectivity
- ➤ Rail and tram history (13% n=5) reference rail and tram history.

Verbatims sample:

I believe TPI House is one of Wallsends most prized jewels and most beautiful buildings and I believe it is currently underutilised.

The foot bridge location is over 150 years old and a historical corridor in Wallsend, you should promote and sign post the area to show the real history of Wallsend's Train and Tram corridor.

Crossing Cowper st is hard and there are SO MANY reasons to cross (skate park, kids playground, sportsground, MacDonalds, wallsend village, etc). It would be great to have a pedestrian crossing



Wallsend Village Mall Area (Wallsend Village street frontages and Bunn Street)

Improvements to the connections between the Wallsend Village Mall and public land had 85% agreement levels. The idea for additional calming devices to be added as part of the existing 40km/hr zone had just over half the respondents support.

Respondents were asked in an open-ended question if they had any other ideas. Themes that arose were traffic, Village carpark and more greenspace.

- > Traffic (25% n=13) safety concerns, agree with traffic calming and limit congestion.
- Village Carpark (18% n=9) safety concerns due to poor visibility, maintenance required.
- More greenspace (12% n=6) more plantings mention of natives. Mentions of trees to reduce heat. With mentions of the park, adding more seating and trees, streetscape and beautify

Verbatims sample:

The intersection of Bunn St and Nelson st needs upgrading. It's too narrow for the amount of buses that come through and the cars that park along that end of Bunn St.

No street parking outside bunn st entrance into village parking (very poor visibility due to parked cars in that area.

Yes, I'm a broken record: more trees!

Imagine being a single parent trying to lug a pram and a toddler from the bus stop to the shops or library; or an elderly person with mobility issues making their way from public transport to the pharmacy in the heat of summer.



Ironbark Creek Channel (South, Central and North) area

All the ideas for the Ironbark Creek Channel had high support rates, widening of bridge and upgrades (90%), greening and tree planting (88%), naturalisation to create water flow and habitat (86%) and public access (86%).




Figure 16 Ideas for Ironbark Creek Channel area

Respondents were asked in an open-ended question if they had any other ideas.

- ➤ Flooding (20% n=12) said slowing the water down widening of channel, mentions of collaborating with Hunter Water.
- Cleaning (16% n=10) rubbish and trolley dumping, requests for more cleaning in and around the creek.
- > Streetscape (11% n=7) beautifying the area and maintenance to bridge.
- > There was also a mention of the creating a community project with community members and local schools.

Verbatims sample:

This needs to be the highest priority. The flooding of Wallsend and the "Ugly" division of Wallsend by this giant concrete eyesore needs to be rectified.

After rain there is so much rubbish down here and it never seems to be cleaned.


To clear the channel and beautify it would be FANTASTIC... right back through the park too

Support development of these concrete channels into artificial wetlands/waterways.



Low Street

Renewing the pedestrian/cycle bridge connection into Federal Park (82%) was the most supported retaining parking on the western side of the road (76%) and providing safety barriers to the edge of the drainage channel (75%).



Respondents were asked if there was anything else they would like to see in this area. Due to small numbers (n=30) a brief overview is given. Some comments related to more greenspace with trees and flowers, traffic issues and support of one-way.

Verbatims sample:

Make sure the so-called shared section is wide enough and that cyclists are aware that pedestrians are using the walkway.

Good idea about parking, more parking is needed here for safer access to federal park for sports



Cowper Street West (including northern end of Wallsend Park).

The most supported idea for the area was to upgrade Ironbark creek channel to increase flood capacity (91%), followed by upgrade shared bridge (85%) and providing missing section of the shared path (81%).




Figure 17 Ideas for Cowper Street West area

Respondents were asked in an open-ended question if they had any other ideas.

- > Traffic (26% n=11) mentions of traffic lights and mixed comments about speed reduction.
- > Road safety (14% n=6) safe pedestrian crossings and improvements to prevent car accidents.

Verbatims sample:

The intersection of Metcalf and Cowper st needs to be improved before you install lights.

Cowper/Metcalf st intersection is very dangerous for pedestrians with traffic turn in and out from many directions.



Cowper Street East

The most supported idea for Cowper Street East was having Façade Improvement Grant Scheme (85%), followed by providing pedestrian refuges helping people cross at the proposed roundabout (78%) and providing the missing section of east west shared path on the northern side of Cowper street (75%).




Figure 18 Ideas for Cowper Street East

Completed works

Respondents were asked if completed works have made a positive difference around Wallsend. They were asked if the upgrade to Tyrrell Street Bridge has made a positive difference to let more flood water through 73% agreed that it has. Completed works at the Wallsend Library included larger disabled parking and allowance for mini-buses.




Figure 19 Feedback on completed works

Social Pinpoint – Ask a Planner Q&A

Recognising that due to COVID-19 public health orders, face-to-face engagement was a risk, community members were invited to 'Ask a Planner' by dropping pins with their questions onto a Social Pinpoint map. A total of 17 questions were received from the community and answers from a City of Newcastle Project Planner are in Appendix 4.



The map also presented information on both planned works and completed works in the town centre.

Respondents were able to see each other's questions and add their own comments or questions.



The topics raised will be considered as part of the Wallsend Town Centre Revitalisation project unless they are outside the project scope. This document will also be distributed directly to those who submitted questions and forms part of the overall engagement reporting.

Placemaking ideas generation

A second Social Pinpoint map was published encouraging individuals to start sharing ideas for making better places and spaces in Wallsend through placemaking. This map remains active and a separate report will be published presenting the ideas and insights by January 2021 at the end of the placemaking engagement period.

6. Information session/briefings

Online information session

One pre-recorded information session was produced and promoted to Councillors, community and key stakeholders. The purpose of the information session was to talk in detail about the staged plans for Wallsend and encourage participation in the survey.

The information session was hosted by Community Engagement and the Assets & Projects teams and published on Thursday 20 August 2020 to the Have Your Say engagement webpage.



Meeting with Wallsend BIA

A briefing occurred between members of the Wallsend BIA, CN's Economic Development Facilitator, Community Engagement, and the Assets & Projects Planner. Concern was raised around restricting access to the Wallsend Baptist Church in CN's proposed plans. BIA members advised they would assist in promoting the community engagement survey and social pinpoint to their local networks.

7. Next steps

Alongside the community engagement outlined in this report, Phase 2 of community engagement focuses on placemaking, seeking information on locations within the Wallsend town centre that community members would like to see activated, updated or issues around safety addressed through design.


Recognising that Wallsend has a demographically vulnerable and growing population, and that the geographical context of the suburb makes it vulnerable to climate change impacts (including increasingly prolonged high summer temperatures and more frequent flooding), ongoing engagement is planned with the relevant members of the community and stakeholders to seek solutions to these issues.





Wallsend gets \$2 million overhaul

City of Newcastle is investing \$2 million to improve traffic and pedestrian conditions in Wallsend's local centre while opening the conversation on its long-term masterplan.

City staff will consult with the Wallsend community over the next month on local improvements ahead of a project to replace the busy Kokera/Cowper Street roundabout with traffic lights.

A joint public domain-flood mitigation program over the next 12 months includes design of the Boscawen and Nelson Street bridge replacements - to facilitate widening and naturalisation of the Hunter Water owned Ironbark Creek channel.

Flood mitigation work will also be completed on the channel within Wallsend Park, along with completion of a new shared pedestrian and cycle path.

Lord Mayor Nuatali Nelmes said the City's local centres program would increase safety for pedestrians, cyclists and motorists and improve the overall look and appeal of commercial centres.

"As we have shown with upgrades to the Beresfield and Carrington town centres, the work will significantly improve the appeal of Wallsend with high-quality infrastructure, such as new seating, street trees and landscaping," the Lord Mayor said.

"Wallsend is a suburb brimming with history and character, which is why it's so important we work with the community to determine what's important as we make long-term improvements in the area.

"I encourage everyone to take part in the community engagement program for Wallsend before future projects transform Cowper Street into a high pedestrian activity area with a reduced speed limit and safer connections."

In the past few months, City of Newcastle has completed the replacement of Tyrrell Street Bridge at a cost of \$3.3 million and committed \$20.7 million to reconstruct and raise the two other bridges as part of an overall flood-mitigation scheme.

Detailed design of upgraded traffic lights for the Nelson Street and Cowper Street intersection and a proposed roundabout at Cowper Street and Newcastle Road will also be carried out in the 2020/21 financial year.

The local centre overhaul is part of an \$8 million investment into the revitalisation of eight suburban commercial precincts in the 2020/21 financial year.

Local centres and commercial precincts set for overhauls or planning work under the 2020/21 budget include:

 Wallsend (\$2 million) - New traffic lights at the intersection of Cowper and Kokera Street, including stormwater upgrades and completion of a missing section of shared pedestrian

and cycle path at a minimum width of 2.5m as part of an important regional east-west cycle route.

- Llewellyn Street, Merewether (\$2.2 million) Renewal of footpaths and drainage to make
 the shopping, dining and health care hub safer and more user friendly. The work includes
 the introduction of comfortable, fixed street furniture, new shade trees and low-level
 gardens.
- Joslin Street, Kotara (\$1.4 million) Upgrade of the roadway, footpaths and drainage between Rae Crescent and the Joslin Street shops. The project will also deliver a new public open space based on community feedback.
- Mitchell Street, Stockton (\$1.3 million) Footpath widening and pedestrian access plus safety improvements between Crown and King streets, with drainage upgrades and new street trees.
- Shortland (\$500,000) Consultation currently underway with residents and businesses to have their say on upgrades to the Sandgate Road local centre, including pedestrian safety improvements and new street furniture.
- James Street Plaza, Hamilton (\$200,000) Detailed design and construction set to follow community engagement to develop artwork and heritage interpretation.
- Orchardtown Road, New Lambton (\$200,000) Feedback from recent community engagement is being integrated into the Public Domain Plan and future design of the local centre.

Wallsend currently is home to newcastles oldest mosque. I would suggest improving the pathways around it, they get quite heavily used and are not in the best condition, also have no pedestrian crossings.

I would also suggest increasing the signage for the wallsend electric vehicle charger, it's not at all obvious and a great asset to the community.

If the left-turn from Nelson Street to Cowper St is to be retained there should either be a pedestrian crossing across Nelson St for that lane or make a left only turning lane part of the traffic lights, with a 'left turn available after stopping' treatment.

What is proposed for the existing share shelter spot? It is definitely underutilised. This could also be a good place for the heritage tram and indigenous plantings, if sight lines are able to be maintained.



Furthermore, on Cowper St travelling West, Nelson St is a bit of a bottleneck as many cars get stuck behind cars turning right onto Nelson. I believe TPI House is one of Wallsends most prized jewels and most beautiful buildings and I believe it is currently underutilised. I understand that currently it is owned by Council and available to be rented out as meeting rooms. I believe Council should lease out these premises to be used as a commercial cafe or restaurant so that it becomes more accessible to the public. For example, the cafe at Signal Box in Newcastle, along the old rail corridor is a shining example of this working. I ordered a coffee from there recently, and felt like I was a part of Newcastle history, observing the old building and enjoying the scenery. Furthermore, the signage visible through the windows on Cowper St is dusty and boring, this building should be brought to life again. I've never been in there despite wanting to (case in point) however I suspect some of the meeting rooms could be retained for bookings, if there is currently demand for this. For such an important, highly visible historic building, why should TPI organisation retain exclusive use? It should be available to the public to see and enjoy for the price of a cup of coffee, rather than exclusive use as meeting rooms. It would also encourage more people into the area, and be a place for Wallsend residents to meet, build community, share in our great history. There is already ample parking and is highly visible, it is already geared for commercial opportunity. Wildflower (no association to me) may be interested in this lease as they appear to do very well at their current location on Cowper St, however parking difficulties make access a safety issue. Whilst a commercial fitout of the building may be costly, compared to other rejuvenation works in Wallsend, I think this could be one of the best value for money improvements to Wallsend culture.

Some of the trees here are too big, likely leading to antisocial behaviour due to reduced sight by the public. Trimming the trees back would also show more of TPI House on the Dan Rees side.

Please don't remove the walkway and pedestrian crossing from this space. I prefer to walk to space then next to the road on Cowper street.

I would very much like to see the car park built over and units built so that seniors could live and have close access to shopping.

I'm a resident near here and I can attest to their being traffic and safety issues along Bunn St. Particularly late at night, there's a number of vehicles (often with loud exhausts!) which race down here at what must be very high speeds. Traffic calming devices are certainly supported.

The Public land on Bunn X Tyrrell could do with some more tree and shrub planting too.

The Return and Earn is in the wrong place here and means large trucks have to continually drive through Wallsend Streets to get here from Summerhill. Council needs to reject the industrialisation of the city centre and veto this. It's a public safety issue, not just the truck movements but the noise pollution. The trucks make a horrendous noise emptying the bottles. It should be moved far away from residences and a large carpark where people are within close vicinity. I have reached out to Cleanaway/TOMRA in the past and they have been hopelessly uncooperative after I've expressed concerns, including ignoring what is on-the-ground community feedback. I don't dispute the environmental value of the scheme but it can't be achieved to the detriment of nearby residents. This is an opportune time for Council to intervene on grounds of safety and town planning, I implore you to listen to feedback and ensure this is removed to a more common sense location.

While bridge upgrades are helpful in flood mitigation, looking at other factors seems to be no agenda. As each new development on the ridge between Lake Road and the Link road is completed more runoff feeds into the creek. This flows down and meets Ironbark Creek before it enters the town.

You are better off providing safer parking facilities along Brooks St to help families access the skate park. The only parking available for Wallsend park is along Brooks St and there is no shoulder (ie wall on east side and steep batter on west) to unload bikes or skate boards and children have to get directly out into traffic racing along Brooks St. With cars parking on both sides of Brooks St, there is insufficient width for two cars to past. I've witnessed many 'close calls' by trucks struggling to stop in time for turning or parking cars. Furthermore, the speeds they do down Cowper seem to already be in excess of 60kmph.

I do not feel the area should be slowed to 40kms. The safety of pedestrians would be better guaranteed with a concrete island! Possibly hundreds of pedestrians cross that road to visit wildflower cafe daily and no one is bothered to use the traffic lights to get over the road unless they are walking on foot via Nelson st or Cowper street. However, most patrons of the cafe park their cars either in front of the bus stop or in the adjacent car park. Please consider a traffic island in front of, or close to wildflower cafe!
