4.2 Newcastle Ocean Baths

The Manager Assets and Projects provided an overview of the Newcastle Ocean Baths infrastructure.

During the discussion it was noted that:

- 4.2.1 CN released the redevelopment expressions of interest (EOI) for Merewether and Newcastle Ocean Baths on 2 November 2019. The EOI closes on 12 December 2019.
- 4.2.2 Rehabilitation works were previously undertaken in 2007/2008. Demolition of the northern pavilion was completed in 2017. The western facade was retained with structural supports however the cathodic protection has not been effective. The central and southern pavilion remain in use. The whole façade is in extremely poor condition due to construction material/technique, age and location.
- 4.2.3 The facade is considered by many to be an iconic structure and is important to the community.
- 4.2.4 Any redevelopment would be subject to a DA process.

ACTION: Manager Assets and Projects will contact CN's Communications team in relation to the community engagement opportunities.

6. Notice of Motion 27/08/19 - Youth Mock Council - Netting on Drains

6.1 The Notice of Motion and Youth Council Motion were tabled.

The Manager Assets and Projects provided an overview of CN's Stormwater Quality Improvement Devices (SQIDS).

During the discussion it was noted that:

- 6.1.1 The Youth Council identified the need for stormwater pollution control.
- 6.1.2 CN currently has 379 devices with 90 devices proposed over the coming years (a 23% increase).
- 6.1.3 Recent engagement surveys have found that the environment is a key issue for the community.
- 6.1.4 Nets are highly visible but unsightly, other SQIDs are in operation but may go unnoticed by the community due to their design and location. Lake Macquarie City Council has installed informational signs around SQIDs to explain their function.

ACTION: Manager Assets and Projects to raise the potential for educational signage with CN's Communications team.
