

City of Newcastle is proposing road names for four (4) new roads in Fletcher.

This is a new greenfield development forming Stage 10 of the Outlook Estate. These roads need to be named to facilitate addressing to aid emergency service location and service delivery. Please see the below table and attached location map (Attachment 1):

	Proposed Road Name	Name Origin	Description
1.	Koteliko Crescent	Awabakal word meaning "to think".	The road begins where Tiraal Drive ends and continues in a crescent shape in a northern direction for a total of 300 metres before rejoining Tiraal Drive.
2.	Pilapai Way	Awabakal word meaning "valley".	The road begins where it intersects with Tiraal Drive and continues in a north-western direction for 85 metres before coming to an end where it intersects with Brookfield Avenue.
3.	Tiraal Drive	Awabakal word meaning "branch of a tree".	The road starts where it intersects with Minmi Road and continues in a northern direction, then in an eastern direction, then in a southern direction for a total of 695 metres, before coming to an end where Koteliko Crescent begins.
4.	Wollotuka Circuit	Awabakal word meaning "eating and meeting place".	The road begins where it intersects with Tiraal Drive and continues in an eastern direction, then in a southern direction, then in a western direction, then in a northern direction for a total of 545 metres before intersecting with itself, forming a loop.



Submissions

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed road names. The submissions must specify:

- the grounds of objection to the proposed names (if any).
- quote 'Fletcher Road Naming November 2021' in the title of the submission.
- include the submitter's name, address, and daytime contact number; and
- where possible, an email address.

Please note: Submissions will only be considered that directly relate to the proposed road names. Any references to the approved development are unable to be considered as part of this road naming process.

Submissions must be made in writing and submitted via e-mail or post. Where possible, City of Newcastle prefers to communicate with submitters via email to support sustainable environmental practices and improved timeliness of any correspondence.
