

## **Exhibition**

City of Newcastle is formalising road names for seven (7) private roads in Elermore Vale. These road names have been approved by the NSW Geographical Names Board (GNB) and are currently in use. City of Newcastle is placing the names on public notice and inviting submissions from the public prior to formal endorsement by the GNB.

These roads have been named to facilitate addressing to aid emergency service location and service delivery. Please see the below table and attached location map (Attachment 1):

	Road Name	Name Origin	Extent Description
1.	Butcherbird Crescent	Native bird name	Extends southwest from Frogmouth Boulevard, then northwest and then northeast to rejoin Frogmouth Boulevard.
2.	Frogmouth Boulevard	Native bird name	Extends northwest from Lake Road between 154 and 156 Lake Road, Elermore Vale.
3.	Lapwing Street	Native bird name	Extends northeast from Frogmouth Boulevard to Magpie Avenue.
4.	Lark Street	Native bird name	Extends northeast from Frogmouth Boulevard to Magpie Avenue.
5.	Magpie Avenue	Native bird name	Extends northeast from Frogmouth Boulevard, then northwest to the boundary of the development.
6.	Pardalote Place	Native bird name	Short road extending southwest from Frogmouth Boulevard.
7.	Wattlebird Crescent	Native bird name	Extends southwest from Frogmouth Boulevard, then northwest and then northeast to rejoin Frogmouth Boulevard.



## **Submissions**

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed road names. The submissions must specify:

- the grounds of objection (if any);
- quote 'Elermore Vale Road Naming October 2021' in the title of the submission; and
- include the submitter's name, email address, address, and daytime contact number.
