

#### Background

We are proposing to upgrade the crossing to improve safety and help with speeding issues in the area. Due to its proximity to Tighes Hill Public School and shops, the crossing can be very busy, especially during the before and after school period. Traffic calming, additional lighting and signage are all part of the proposal.

The proposal to raise the crossing was included in the Tighes Hill Local Area Traffic Management Plan update of June 2017 and has in-principle support of the Newcastle City Traffic Committee. Street lighting at the new crossing will be reviewed as part of the project scope, to determine if upgrades are required to meet the relevant Australian Standards.

This consultation is being undertaken to ensure that the community is informed and can raise any concerns, prior to reporting to Council for approval.


#### What is proposed

We are seeking feedback on a proposal to upgrade the existing pedestrian crossing on Elizabeth Street near Union Street, Tighes Hill to a raised crossing with kerb extensions.

#### Proposed works include:

- Construction of a raised pedestrian crossing in Elizabeth Street near Union Street, Tighes Hill, at the location of the existing pedestrian crossing
- Construction of kerb extensions
- Upgrade of street lighting
- Signage and line marking works (including advanced warning signage for the raised crossing)

To improve visibility of the crossing, one parking space will be removed on the southeast corner and one on the southwest corner.

1	17/12/2021		Tighes Hill	Yes, with changes	Respondent supports the proposal. Respondent notes limited parking in the area and queries if a parking space can be reinstated on the northwest corner west of the kerb extension. Respondent queries whether the No Stopping will be enforced, noting that illegal parking is already rife. Respondent queries if time limited parking and resident permits have been considered. Respondent queries if street tree planting is being considered in this upgrade.	The length of No Stopping on the approach to a pedestrian crossing is set by standards and varies according to the width of the kerb extension (the wider the kerb extension, the shorter the length of No Stopping). The kerb extension is proposed to be lengthened. Timed parking is outside the scope of the current project but could be considered in future, subject to analysis of the existing situation and wider consultation. Establishment of a resident permit parking scheme is subject to Transport for NSW guidelines, incorporating analysis and survey. As above, it is not within project scope but could be considered in future. Kerb extensions will incorporate landscaping, if possible. Street tree vacancies throughout the city have been identified.
2	18/12/2021		Tighes Hill	Yes, with changes	Respondent supports the proposal but considers there should be No Stopping in front of 28 Elizabeth Street to improve sight lines for traffic turning right from Union Street into Elizabeth Street west.	Sight lines will be assessed during detailed design and design road safety audit. An additional kerb extension on the northeast corner is proposed.
3	18/12/2021		Tighes Hill	Yes, with changes	Respondent strongly supports the proposal but considers changes are required to fully address current issues. Respondent notes that illegal parking already occurs, obscuring the crossing for eastbound drivers and for traffic turning west from Union Street. Respondent states that the kerb extension on the north side must be lengthened to finish at the No Stopping sign and prevent illegal parking and failure to do this would be unacceptable.	Suggestion for lengthening of the kerb extension is supported and will be addressed in detailed design.

Respondent also requests maintenance throughout Tighes Hill, including addressing potholes, road resurfacing, completion of installation of ramps, addressing cracks and gaps in footpaths and pruning and maintenance of trees.	Support for proposal noted. Landscaping options are to be considered as part of detailed design. Request for maintenance has been forwarded to Assets and Projects for consideration in future programs.
5	20/12/2021		Tighes Hill	Yes, with changes	Respondent supports the proposal but suggests that a parking space be removed in front of No. 28 to improve sight lines to the east when exiting Union Street. Respondent suggests removal of the power pole outside the café (Praise Joe Café) and restrictions on congregating, to improve sight lines to the west when exiting Union Street.	It appears illegal parking is occurring on the northeast corner of the intersection. A kerb extension on the northeast corner is to be implemented, to discourage illegal parking. Further investigation of power pole and potential relocation required.

Respondent states that the 40km/h speed limit is constantly exceeded by motorists and proposes that, to further restrict speeding, road humps be installed along the entire length of the street.	Noted. The spacing of local area traffic management (LATM) devices on Elizabeth Street is somewhat greater than the recommended spacing of 80 - 120 metres. This project, to upgrade the crossing, is one of series of projects recommended in the Tighes Hill LATM Review 2017. Monitoring of speed will be undertaken following construction of the raised crossing, should it be approved, to confirm the need for additional devices. A future stage, to reconstruct the threshold at Kings Road, will be expanded in scope to include additional traffic calming measures on Elizabeth Street, should surveys indicate they are required.
