PURPOSE

To report on an independent evaluation of City of Newcastle's COVID-19 Community and Economic Resilience Package (CERP).

BACKGROUND

On 24 March 2020, Council adopted the \$5.5m CERP in response to the then emerging COVID-19 pandemic crisis; one of the first government response across Australia.

The package comprised 10 programs over three tranches between April 2020 and June 2021 with a suite of financial relief, business and community supports – including interest free rate payment plans, rent reductions on council buildings, free online training, and community grants to support vulnerable and at-risk community members.

The CERP aimed to mitigate the impacts of the COVID-19 pandemic for Newcastle through:

- i) Direct action to support community wellbeing;
- ii) Timely responses to address cash-flow for small business;
- iii) Innovative programs to provide long-term strategic legacy benefits for the city;
- iv) Collaboration with partners and support for existing initiatives; and
- v) Financial responsibility for the long-term sustainability of the organisation.

The Hunter Research Foundation Centre was commissioned to evaluate the CERP.
