

1. Background

At the City of Newcastle (CN) Council meeting on 27 November 2018, Councillors resolved to have a public domain plan prepared for Shortland Local Centre under the Local Centres Public Domain Infrastructure Renewal Program. In April 2019, CN met with Shortland businesses to gain feedback on key issues in the area.

In June 2020, CN invited Shortland residents and visitors to share their views on:

- Pedestrian and cycling access and safety in the area
- Traffic management
- Parking times and zones
- The 'look and feel' of the area
- Crime and antisocial behaviour.

The feedback captured in June 2020 will help CN develop a design for Shortland Local Centre and inform future placemaking activities. Construction will commence in the 2020/21 financial year.

2. Engagement activities

Consultation ran between 15 – 29 June 2020. The key outcomes sought were:

- Confirm issues for improvement, which will feed into the Shortland Local Centre concept design
- Raise broad community awareness (suburb-wide) about the local centre upgrades
- Understand what the community most values about the Local Centre.

Feedback from the community was captured predominantly via an online survey. However, some community members provided feedback via downloadable PDF surveys and written email correspondence.

CN Civil Services Coordinator, Andrew Wood, spoke to local businesses in person during the consultation period and called community members in person where requested.

3. Marketing and communications

During the consultation period a communications campaign was implemented to raise awareness of the upgrades set for Shortland Local Centre and to promote opportunities for the community to provide feedback via an online survey. The aim of the campaign was to encourage active participation of Shortland residents and visitors. The communication materials are available in Appendix 1: Communications.

The online survey was promoted through the following channels:

- Have Your Say website
- CN website home page
- Shortland Local Centre website
- Targeted Facebook campaign
- Onsite signage and posters at Shortland Local Centre
- Direct email to Newcastle Voice stakeholders
- Distribution of flyers to surrounding residents.

4. Key findings

During the consultation period, CN received:

- 277 completed online surveys
- 6 downloadable PDF surveys
- 4 written submissions.

The results of the online and PDF surveys are outlined in this chapter. The full survey format can be found in **Appendix 2: Online survey format and PDF survey.**

De-identified written submissions can be found in Appendix 5: Written submissions.

Online survey results

A total 277 community members completed the Shortland Local Community Centre online survey between 15 - 29 June 2020. The online findings are outlined below.

Respondents were asked the following question:

Please rank in order of priority the following aspects of your neighbourhood centre that you would most like to see improved. (1 = highest priority, 8 = lowest priority.)

The top three priorities identified by the community are:

- Improving the look and feel of the area (31%)
- Pedestrian safety, access and connectivity (23%)
- Reducing crime and antisocial behaviour (15%).

What are the top three things you most value about Shortland Local Centre?



More than half of respondents (60%) commented that the current local small businesses in Shortland are an asset to the community. This was followed by respondents commenting on the convenience of the local centre as an option for shopping/services (32%). The community atmosphere is also an aspect that residents and visitors' value about Shortland Local Centre (28%).




Figure 2: What are the top three things you most value about Shortland Local Centre?



What do you want to see more of?

Parking was the key concern for 36% of respondents, particularly in relation to the on-street parking occupied by residents who live in high-rise developments. Respondents (27%) said they would like to see a general refresh to the look and feel of the area, as well as the introduction of a local grocer (21%) and sit-down restaurant/café (21%).




Figure 3: What do you want to see more of?

PDF survey findings

Five pdf surveys were submitted to Council via email and one was submitted via post.

Please rank in order of priority the following aspects of your neighbourhood centre that you would most like to see improved. (1 = highest priority, 8 = lowest priority.)

Two out of three submissions placed pedestrian safety, access and connectivity as the highest priority, as reflected in the online survey results. This was followed by a third of submissions who nominated traffic management.

What are the top three things you most value about Shortland Local Centre?

Similarly to the online surveys completed, feedback showed respondents valuing the local shops as well as Shortland's community 'feel' and proximity to facilities such as the inner city bypass.

Chemist, butcher, Post Office and paper shop.

Location & access to the Local shopping centre

Proximity to Newcastle Inner City Bypass

Rural charm of Shortland.

Proximity to natural and man-made facilities (e.g., Wetlands Centre, University of Newcastle, inner-city bypass, future RVRT and related cycleways).

Retention of local charm (needs to retain its positive vibe, and not be over-developed).

Could develop as a mini tourist hub - cafes, bike shops, tourist information displays - capitalising on proximity to transport, cycleways, wetlands, golf course, university, etc.

What do you want to see more of?

Similarly to the online surveys completed, feedback showed respondents would like to see improvements to parking (including availability and facilities), improved cycleway connections, better footpaths a grocery shop and improved traffic flow/traffic calming.

Table 2: What do you want to see more of?

Traffic lights at the corner of Bardia Road and Sandgate road Shortland.

More parking available at the shops.

Less trucks on Sandgate road – major problems.

A small grocery shop.

Fruit and vegetable shop.

Safer access from road on to street shops (too steep for elderly).

Footpaths. Make the main streets all level. Not only on Sandgate Road but in Mawson Street and Marton Street. More able for older people to walk without worrying about falling over.

More police.

Parking only on one side of the road on Hanson Place.

Better traffic management; too many speeding vehicles!

While the proposed Shortland Local Centre upgrade covers only a small area, it is important to view Shortland as a Local Hub - facilitating connectivity to a range of natural and man-made facilities (see above). In effect, Shortland will be the south-eastern gateway to the Richmond Vale Rail Trail (RVRT) - with the potential to attract large numbers of visitors. It will also potentially be a cycleways hub, connecting the Shortland to Tarro section of the RVRT (an active transport priority) to the Wetlands Centre, University of Newcastle, and the wider cycleways network. Preparing for the opportunities that will arise, and freshening up the Local shopping area (signage, tourism promotion, toilet and rest stop facilities, bike facilities, modest accommodation, etc) are all part of the desired upgrade mix.


5. Next Steps

Appendix 5: Written submissions

Written submissions from the public are included below and have been de-identified.

Individual

- Shortland Shopping Centre garbage bins in front of the shopfronts should be emptied more frequently. Often the garbage is hanging from the bins - days ahead of collection, we walk our dogs through this area daily and have observed this for
- The Council should get with the times, all the new developments on the eastern side of Sandgate Road should have had industrial size bins within the boundaries of each property. Please come and take a drive along Sandgate Road the day before and a few days after Garbage Collection day and you will observer that the bins sit on the footpath and on the roadway between the cars parked on the public road due to the lack of parking on the development sites.
- On the corner of Vale Street and Sandgate Road from the lights on the southern side of the footpath heading to the University and Golf Course there is a Cattle Pad, we call the rut, where the Uni students have to negotiate the mud and unfinished footpaths. This is due to the work from the gas company and the waterboard when developing the Aveo Retirement Village and Golf Course redevelopment. Perhaps some of the money from all the ongoing development sites could fund the completion of a safe and accessible footpath for a high foot traffic area.
- it is time for the road to be resurfaced from Moore Street to Sandgate Road as it is in a disgraceful state. Since 1988 when the Newcastle Link Road was finished, and the signs of the main road disappeared nothing has been done.

Individual

- I would like to see a load limit introduced for Sandgate Road. Too many large trucks, many with dog trailers are using Sandgate Road instead of the A37 bypass road. This is particularly dangerous, especially on garbage collection days, when rubbish bins are placed on the roadway outside the parked cars on the southern side of the road.
- Install a "left turn only" sign at the intersection of Marton Street and Sandgate Road to avoid traffic congestion at peak times. Traffic trying to turn right is held up by the Sandgate Road traffic, preventing any other vehicle turning left. If someone needs to turn right at this intersection, they only have to use a little thought and turn left and do a "U" turn at the nearby roundabout, or travel down Mawson Street to the traffic lights. This has been a problem since the concrete pedestrian island was installed in the middle of the road.
- Make Mawson Street a one-way street (west to east) during weekdays from say 8.30 A.M. to 5.30 P.M. This street is particularly dangerous during this time, with hospital traffic parked both sides of the road, and bus and truck traffic.
- Instigate a local ordinance that rubbish bins must be removed from the kerbside the day after rubbish collection. I believe that some Sydney councils have this ordinance, whereby people are fined for leaving their bins out longer than 24 or 48 hours. The southern side of Sandgate Road is starting to resemble a third world country, with bins left out the front of flats for weeks. The flat residents seem to be temporary residents and take no pride in the appearance of the area. Other rubbish is left piled up on the kerbside outside some flats for weeks. This also occurs outside other flats in the area.
- Impose a moratorium on the building of any more flats in Shortland. The proliferation of flats in the area has caused a steady erosion of the previous way of life and increased the incidence of anti-social behaviour.



- Ensure property developers provide more than one carpark for each future flat built in the area. The carpark should be able to be used by someone who has the necessary co-ordination and driving skills to park a vehicle larger than a Nissan Micra in it. Currently, it seems that the residents of each flat in the area have two or more vehicles, which are left parked in surrounding streets, since very few of the residents are willing or able to park a vehicle in it.
- Extend timed parking along Sandgate Road from the Mawson Street intersection to Vale Street and enforce the current regulations a bit more enthusiastically.
- Get someone from council to come and inspect Sandgate Road on a Wednesday rubbish collection day to see the absolute disgrace with all the rubbish bins clogging the southern side of the roadway. It certainly wouldn't be permitted in Merewether!


Individual

- The project scope has been minimised presumably to keep costs down.
 - However, it excludes K&M Mechanical & the two service stations & other properties in between. While the existing scope seems to be based on Zoning B1 (Neighbourhood centre) the chemist from LEP2012 is zoned R2 as are the aforementioned properties. Therefore, zoning should not be a consideration.
 - In addition, there are two schools & two Churches (Also zoned R2) in the immediate vicinity which are a part of the local centre. Why are these not
 - The existing scope precludes the eastern footpath from any improvements. Whv?
 - No thought has been given for business opportunities that may arise from initiatives fronting the east side apartments.
- The Tarro Newcastle University off-road pathway is currently planned to go through the Shortland local centre which is a mistake.
 - The pathway could only go on the east side fronting the apartments as the west side would have to many pedestrian (Children) & cyclist conflicts. Which precludes the purpose of a pathway through the local centre to access businesses. (Separated by Sandgate Road which is extremely hard for pedestrians to cross during peak hours).
 - Has Council told business owners of the proposal to put the pathway though the local centre?
 - A far better alignment for the pathway is to cross Sandgate Road at K&M Mechanical then via the accessway between east side property boundaries & the motorway noise walls/guardrail.
- Gateway approach The current project scope means motorists vision / sight distance is limited to when they approach:
 - o Northbound to after they pass the crest at Vale Street
 - Southbound after rounding the corner to Mawson Street.
 - Clearly this limited approach is unsuitable to give sufficient time to signal to drivers a changed traffic environment at the local centre. Hence the reason to include the other properties (Churches, schools, servo's & Mechanical repair shop). Otherwise the vista will give the appearance of a mean & nasty afterthought to our local centre.
- Tree Planting The eastern footpath is excluded from the scope thus any tree planting would need to be on Sandgate Road as the existing footway will presumably need to be retained for the pathway full width. Blisters in Sandgate Road will limit access & parking to east side apartments, thus probably no improvements on the east side verge?
 - Tree planting & street furniture on the west side only will give a lop-sided view to the local centre.



- Garbage bins There is a continuing problem of waste collection from the east side apartments approaching 100+ bins which now become a traffic hazard during the southbound morning peak hour. Waste collection needs to be consolidated to 1 or 2 bins per complex.
- Parking Limited on-street parking precludes longer stay parking for businesses (E.g. grocery store, butcher, hairdresser, chemist) where passing motorists & locals seek to pick-up from a secure parking space way from through traffic.
 - With cooperation from business owners an opportunity exists to create offstreet parking and access roadway between Mawson Street & Hansen Close behind the west side shops.
- Blisters within the roadway to provide seating, trees & outdoor eating etc will need to be located so as not to impede vehicle access to on-street parking. And conflict between kerb side eating & passenger access to/from vehicles will need to be managed sensitively.



We are seeking feedback on proposed public domain upgrades to improve pedestrian safety and reduce driver speeds along Sandgate Road in the Shortland Local Centre area.

The proposed changes are:

- Implementation of a 40km/hr speed limit through the Local Centre area.
- Installation of landscaped kerb extensions or islands, with speed cushions at the northern entry point to the HPAA
- Installation of landscaped kerb extensions or islands, with a pedestrian refuge at the southern entry point to the HPAA.
- · Speed cushions in the centre of the Local Centre area.
- · Realignment of kerb ramps at Mawson Street.
- Installation of a new landscaped kerb blister or island on Sandgate Road south of the Mawson Street intersection to protect parked cars from oncoming traffic.
- Relocation of the disabled parking space from Hansen Place to achieve appropriate grade.
- Installation of a new landscaped kerb extension or island at the entry to Shortland Local Centre to assist pedestrians crossing Hansen Place.
- Public domain upgrades including new footpath and street furniture between Mawson Street and Hansen Place.

All existing parking arrangements are retained unless shown on the plan overleaf. Street furniture including bins, seating and bicycle racks will be located in consultation with business owners.

What happens next?

Following public exhibition we will report to the Newcastle City Traffic Committee, ahead of seeking endorsement from elected Council.

We anticipate commencing construction of the upgrades toward the end of this financial year. We will update the community on progress throughout the year.
