Shadow Minister for Local Government Greg Warren was bemused by the comments given the state government's refusal to introduce a stimulus package for councils throughout the state – an initiative NSW Labor has repeatedly called for.

Mr Warren urged the Minister to stop sitting on the fence and demand the Treasurer and Premier formulate and deliver a much-needed stimulus package for councils.

The stimulus would not only provide councils with a much-needed financial injection, but it would also help fast-track shovel-ready projects and ensure employees remained in the workforce.

"Councils are bleeding money in an effort to soften the impact of COVID-19 on their communities," Mr Warren said.

"Most are dipping into their cash reserves to do so, but as we know there are a lot of councils who simply don't have the ability to do this for an extended period of time – or at all.

"If the Minister doesn't deliver the stimulus funding councils need to stay afloat it's people who will wind up paying with their jobs.

"Stimulus would provide councils with a much-needed financial injection, keep people in a job, maintain services and fast-track 'shovel-ready' projects."

"If the state government supports councils through this COVID-19 crisis then councils can support their communities – it's that simple.

CORONAVIRUS: UP TO 45,000 COUNCIL JOBS AT RISK

The coronavirus has led to closure of many council facilities putting up to 45,000 jobs at risk.

Currently ineligible for the JobKeeper package local councils are already laying off thousands of employees.

Sutherland Shire Council, in the Prime Minister's own electorate, has already stood down 260 casual workers.

Councils receive revenue from two main sources; fees for community facilities, like pools and community halls, and the rates they charge for garbage, roads and park maintenance.

With most community facilities closed, councils face a significant loss in revenue. Blacktown Council alone is losing 1.7 million per month in fees for services they have had to close.

With many councils about to issue rate notices, revenue will also be massively under pressure as the economic impact of the coronavirus hits ratepayers.

Many councils are preparing for a greater level of rate defaults, or deferrals of rates, to help ratepayers.

The federal government has said that help for councils and their staff is a matter for the states.

The fact is councils and council workers need the help of both federal and state governments.

There are a number of ways this problem can be fixed.

Any solution should involve a commitment of no job losses and rate relief to those that need it.

Local government is the level of government closest to every Australian. The people it employs and the services it provides are the backbone of our local communities.

Not only are councils important now, they will be incredibly important as we come out of this crisis. They will drive the community infrastructure projects to get this economy going again.



We all know that we are in an unprecedented, difficult time. But it is not the time for any local government worker to be stood down or let go.

Local government workers form an essential part of community support and deliver a wide range of essential services.

Local Government workers are at the frontline during national disasters, and in the aftermath, always the first to provide the support that is required. There is no more shining example of this than during the recent bushfires.

We have been extremely concerned that local government workers who are there for their communities are now being left out in the cold.

This is why we are calling on the Federal Government to take urgent action to secure local government jobs and support to communities.

- An urgent stimulus package to Local Government;
- A review of the decision to leave Councils out of the JobKeeper arrangements;
- Financial assistance, access to funding and grant variations to enable councils to focus on supporting their communities and preserving jobs through this crisis;
- Where rate relief is contemplated or implemented, the Government should fund councils to ensure there is no loss in revenue that goes towards councils delivering support to their communities, during the crisis and recovery stages.

LMM 28/04/20 - LGNSW - COVID-19 FINANCIAL SUPPORT

MOTION

That City of Newcastle:

- 1 Calls on the Federal Government and NSW Government to urgently deliver comprehensive and multifaceted financial support and stimulus packages to local government to enable them to continue to operate effectively and provide essential services during the COVID-19 pandemic.
- 2 Calls for the packages to include the following measures:
 - Increasing Financial Assistance Grants payments to 1% to help councils maintain essential functions and services, acknowledging the increased costs and mounting revenue losses arising from COVID-19 (and drought and bushfire where affected) as well as giving councils capacity to provide hardship assistance to businesses and residents.
 - Immediate financial assistance to support council employees, especially in early education and care.
 - Providing stimulus funding to councils for projects that will help sustain council operations and boost local economies. This could be achieved through increasing or bringing forward funding under existing funding programs or introducing new programs.
 - Increased access to TAFE, VET and other apprenticeship opportunities that council staff can undertake to address skill shortages, especially for staff in non-essential services who are unable to be redeployed.
 - Ensuring that City of Newcastle is not deemed ineligible for any future grant or stimulus funding due to our status as metropolitan or regional, given the ongoing uncertainty that exists regarding this matter between the State and Federal Governments.
- 3 Commends the NSW and Federal Governments on their stewardship during this crisis and commits to working in partnership to protect community health and sustain local economies through this crisis.
- Writes to the Federal Member for Newcastle, Sharon Claydon MP, Prime Minister, the Hon. Scott Morrison MP, State Member for Newcastle, Tim Crakanthorp MP, NSW Premier the Hon. Gladys Berejiklian MP, Federal Treasurer the Hon. Josh Frydenberg MP, NSW Treasurer the Hon. Dominic Perrottet MP, NSW Local Government Minister the Hon. Shelley Hancock MP, Federal Minister for Local Government, the Hon. Mark Coultan, Federal Opposition Leader the Hon. Anthony Albanese, NSW Opposition Leader Jodi McKay MP, Federal Shadow Minister for Local Government, Jason Clare MP and NSW Shadow Minister for Local Government, Greg Warren MP to confirm their support for increased financial assistance and stimulus funding for local government to help councils maintain essential services and employment during the COVID-19 pandemic.

- 5 Endorses Local Government NSW's sector-wide campaign to obtain financial assistance, employment support and stimulus funding for the local government sector.
- 6 Advises LGNSW President Linda Scott of the passage of this Lord Mayoral Minute.

BACKGROUND:

On Friday, April 2020, President of Local Government NSW (LGNSW), wrote to City of Newcastle asking that we endorse the campaign to support the local government sector through the COVID-19 pandemic, which is being coordinated by LGNSW and the Australian Local Government Association (ALGA).

Subsequently, I ask all Councillors to support the local government sector's campaign for assistance in dealing with the health and economic crisis caused by the COVID-19 pandemic.

City of Newcastle is already suffering the consequences of the COVID-19 pandemic, with many of our services to the community closed, and significant financial implications for the City's balance sheet.

I am recommending that we support the campaign, which is being coordinated on behalf of the NSW sector by Local Government NSW (LGNSW) and at a national level by the Australian Local Government Association (ALGA).

City of Newcastle has faced increased costs and at the same time is experiencing declining revenue as more and more ratepayers are forced into financial hardship. The impacts are rapidly escalating.

I commend our staff for doing everything possible to provide support and deliver the services needed to protect community health and keep our communities running during these difficult times. The wellbeing, safety and livelihoods of our staff and our community is our top priority.

However, if additional assistance is not provided, we may be forced to further review service levels, infrastructure maintenance and staff arrangements.

It is critical that the local government sector receives adequate funding and resources to coordinate and deliver the goods and services needed as we navigate through the new challenges presented by COVID-19 and its massive impacts on people and our local economies.

Council needs urgent financial assistance from the Federal Government and NSW State Government to maintain infrastructure, services and employment as well as funding to give councils the capacity to provide hardship assistance to the community.

The measures listed below would be effective and simple to implement:

- Increasing Financial Assistance Grants payments to 1% to help councils
 maintain essential functions and services, acknowledging the increased costs
 and mounting revenue losses arising from COVID-19 (and drought and
 bushfire where affected) as well as giving councils capacity to provide
 hardship assistance to businesses and residents.
- Immediate financial assistance to support council employees, especially in early education and care.
- Providing stimulus funding to councils for projects that will help sustain council
 operations and boost local economies. This could be achieved through
 increasing or bringing forward funding under existing funding programs or
 introducing new programs. Existing Federal funding programs include the
 Roads to Recovery, Bridges Renewal and Road Safety Blackspots programs.
 State programs include Fixing Local Roads, Fixing Country Bridges and the
 Stronger Country Communities programs.
- Further, that City of Newcastle is not deemed ineligible for any future grant or stimulus funding due to our status as metropolitan or regional, given the ongoing uncertainty that exists regarding this matter between the State and Federal Governments.
- Increased access to TAFE, VET and other apprenticeship opportunities that council staff can undertake to address skill shortages, especially for staff in non-essential services who are unable to be redeployed.

PURPOSE

To receive a Practice Note to the Code of Meeting Practice (COMP) to provide for Council meetings to be held remotely by audio-visual link.

RECOMMENDATION

That Council:

1 receive the Practice Note to the Code of Meeting Practice, as set out at **Attachment A**.

KEY ISSUES

- 2 On 25 March 2020 amendments were made with immediate effect to the Local Government Act 1993 (Act) to allow councils to meet remotely, to assist them to manage the risk of transmission of the COVID-19 virus at their meetings and to ensure compliance with Public Health Orders in relation to the COVID-19 pandemic.
- 3 Amendments have been made to the Act to temporarily modify the application of existing provisions of the Act and councils' codes of meeting practice. Any requirements under the Act or councils' codes of meeting practice for councillors to physically attend meetings and for members of the public to be permitted to attend meetings, will be satisfied if attendance is by way of an audio-visual link in accordance with section 747A of the Act.
- 4 The Office of Local Government (OLG) requires councils to take all necessary steps to enact the changes, however councils are not required to make amendments to their codes of meeting practice to give effect to this.
- For abundancy of clarity, the Practice Note to the COMP, as set out at **Attachment A**, has been prepared to provide guidance on the practical delivery of remote meetings to enable Council to meet its legislative obligations. The Code of Meeting Practice as set out at **Attachment B** remains unchanged and the two documents should be read together.
- The amendment to the provisions of the Act are valid for six months and may be extended for up to 12 months by regulation. The Practice Note will operate for as long as the amended provisions of the Act remain in force.

FINANCIAL IMPACT

7 CN's adopted Our Budget 2020/21 provides for arrangements for Council meetings. There is no budget implication in adopting the Practice Note to the COMP.

COMMUNITY STRATEGIC PLAN ALIGNMENT

8 Open and Collaborative Leadership

RISK ASSESSMENT AND MITIGATION

11 CN's adopted COMP ensures Council complies with the Act, Regulation and the Model Meeting Code. As no amendments are required to the COMP, there is little risk to Council in adopting the Practice Note designed to provide clarity.

RELATED PREVIOUS DECISIONS

12 At the Ordinary Council Meeting held on 24 September 2019, Council adopted the Code of Meeting Practice.

CONSULTATION

- 13 No public exhibition process is required as there is no amendment to the COMP.
- 14 No consultation with Advisory Committees was required.

BACKGROUND

15 The OLG has provided advice to councils on the requirements to comply with the amendments to the Act, as set out in OLG circular 20-09 Compliance with social distancing requirements to limit the spread of the COVID-19 virus at council and committees meetings, as set out at **Attachment C**.

OPTIONS

Option 1

16 The recommendation as at Paragraph 1. This is the recommended option.

Option 2

17 Council not adopt the Practice Note to the COMP. This will not negate the requirement for Council to meet in accordance with the requirements of the Act. The Practice Note is designed for practical guidance only and is not a legal requirement. This is not the recommended option.

Practice Note: Code of Meeting Practice



In relation to the COVID-19 pandemic, on 25 March 2020 amendments were made with immediate effect to the Local Government Act 1993 (the Act) to allow councils to meet remotely, to assist them to manage the risk of transmission of the COVID-19 virus at their meetings and to ensure compliance with Public Health Orders.

Councils are required to take all necessary steps to enact the changes in accordance with the advice of the Office of Local Government (OLG) 20-09 Compliance with social distancing requirements to limit the spread of the COVID-19 virus at council and committee meetings

This Practice Note provides for the practical delivery of Meetings remotely, and provides clarity in relation to consequential temporary amendments to the CN Code of Meeting Practice (COMP) to enable Council to meet its legislative requirements.

The CN Code of Meeting Practice (COMP) must be read in conjunction with this Practice Note to ensure compliance with the legislation as amended.

This Practice Note will operate for a period of six months but may be extended to 12 months by regulation if required.

1. AMENDMENT OF MEETING SCHEDULE

At its meeting on 24 March 2020, Council resolved on the basis of current public health advice, to immediately vary its adopted Meeting Schedule by:

- (a) Cancelling or postponing all non-essential in-person Advisory Committee meetings until public health orders are lifted;
- (b) Cancelling in-person Public Voice meetings, and consider alternative electronic means of facilitating Public Voice until public health orders are lifted;
- (c) To reduce unnecessary meetings, scheduling Development Application Committee (DAC) meetings to be held on the same night as scheduled Ordinary Council Meetings; and
- (d) Proceeds with scheduled Ordinary Council Meetings in April and May 2020, with agendas limited as far as practicable to urgent matters requiring the elected council's approval.

Refer COMP: section 5: Scheduling of Meetings, section 11: Order of business, section 17: Public Voice and Public Briefings

2. MEETINGS TO BE CONDUCTED REMOTELY

All references to 'Meeting' or 'Meeting room' or 'Council Chamber' within the COMP should be interpreted as operating within the platform identified to support meeting remotely using audio-visual link.

The amendment to the Act provides that any requirement that Councillors attend a Meeting is satisfied if the Meeting is held remotely using audio-visual links. This means that Councillors are now able to participate in meetings by an audio-visual link instead of attending person.

CN will continue to livestream Council and Committee of Council Meetings (excluding when parts of the Meeting are Closed).

Refer COMP: section 8: Councillor Participation; section 43 Webcasting

PUBLIC ATTENDANCE AND AVAILABILITY OF AGENDA AND BUSINESS PAPERS

CN satisfies the requirements under section 10 of the Act that members of the public be permitted to attend Meetings, by holding Meetings remotely using audio-visual links and livestreaming Meetings using an audio-visual link.

Following the temporary closure of CN's Customer Contact Centre to in-person visits, Agenda and Business Papers are available on CN's website only. No paper copy Agenda or Business Papers will be made available to the public while Meetings are held remotely.

Refer COMP: section 21 Availability of Agenda and Business Papers to the public, section 29 Public; section 43 Webcasting

4. CONDUCT OF COUNCILLORS DURING REMOTE MEETINGS

While Meetings are held remotely, Councillors will not be required to stand.

Councillors continue to be obliged to disclose and appropriately manage conflicts of interest they may have in matters being considered at meetings. Councillors continue to be obliged to remove themselves from the consideration of matters in which they have a pecuniary or significant non-pecuniary conflict of interest.

Refer COMP: section 8 Councillor participation, section 15: Mode of address; section 74 Conflicts of interest - Councillors

5. VOTING

Voting will continue to be conducted by voice, show of hand or by division as required using appropriate processes that support open and transparent decision-making.

Refer COMP: section 27 Election of Chairperson; section 68 Voting entitlements; section 70 Counting of votes; section 71 Voting by division



6. CONFIDENTIALITY AND CLOSING MEETINGS

Councils continue to be able to close Meetings to the public under section 10A of the Act. Where Councillors participate in Meetings held remotely by audio-visual links, they continue to be obliged to protect any confidential information considered at the Meeting. Terms of Reference for the ICLEI Regional Executive Committees (RexCom) 2020

1. General

- 1.1. A Regional Executive Committee (RexCom) for the 2021-2024 term shall be established in the following ICLEI Regions by the end of September 2020:
 - Africa
 - East Asia
 - Europe and West Asia
 - Mexico, Central America and the Caribbean
 - North America
 - Oceania
 - South America
 - South Asia
 - Southeast Asia

1.2. The RexCom should act as a high level strategic leadership, advisory and representation body, preferably consisting of political leaders from ICLEI Members within the region.

Reference: Charter 4.4.1

1.3. Each RexCom should consist of three or five members; each member can be assigned to a specific portfolio. A certain number of special advisor positions can be open. Two of the RexCom members shall be elected Chair and Vice-Chair.

1.4. The RexCom is elected for a three year term.

1.5. The ensemble of the RexComs forms the ICLEI Council.

2. Role

2.1. The RexCom represents ICLEI Membership from the relevant ICLEI Region and makes decision on policy to be applied in the region.

2.3. RexCom members shall make necessary arrangements to meet with ICLEI Regional Director at least once a year.

2.4. The RexCom shall designate a regional representative to the ICLEI Global Executive Committee (GexCom) from among its ranks. The designated member should make necessary arrangements (including financially) to take part in GexCom's meetings, usually once per year at an ICLEI international event Reference: Charter 4.2.2

2.5. As part of the Council, RexCom members participate in the definition of the general direction for the Association and in the amendment of the ICLEI Charter and By-laws. The Council also elects the GexCom. Members of the RexComs shall also ensure they attend Council meetings. For the 2021 – 2024 term, the regular meeting of the Council will take place in Malmö, Sweden in April 2021, on the occasion of the ICLEI World Congress 2021.

3. Eligibility

In order to be eligible to be part of the RexCom, one should:

3.1. preferably be an elected or appointed political leader from an eligible ICLEI Member within the region.

3.3. submit the appropriate candidacy documents in due time, responding to the call for candidates.

4. Designation

4.1. A list of candidates for the RexCom should be proposed from among candidacies received by the Regional Director and the ICLEI Secretary General, after appropriate consultations with the incumbent RexCom, and/or Members in the region.

4.2. The proposed composition for the RexCom should then be submitted to a vote by ICLEI Members in the region. The vote should be open for at least four weeks. Only votes submitted by Members who are not more than one year in arrears for the payment of their membership fee shall be considered valid.

4.3. At the expiry of the election period, should the quorum be reached, the proposed composition of the Council should be considered approved and the RexCom elected. The results should then be submitted to the ICLEI President for review. After verification by the President, the President, Secretary General and Regional Director communicate the establishment of the RexCom and declare the commencement date of its term.

PURPOSE

To report on City of Newcastle's (CN) monthly performance. This includes:

- a) Monthly financial position and year to date (YTD) performance against the 2019/20 Operational Plan as at the end of March 2020.
- b) Investment of temporary surplus funds under section 625 of the Local Government Act 1993 (Act), submission of report in accordance with the Act and clause 212 of the Local Government (General) Regulation 2005 (Regulation).

RECOMMENDATION

That Council:

1 Receives the Executive Monthly Performance Report for March 2020.

KEY ISSUES

- At the end of March 2020 the consolidated YTD actual operating position is a surplus of \$12.8m which represents a positive variance of \$6.5m against the budgeted YTD surplus of \$6.3m. This budget variance is due to a combination of income and expenditure variances which are detailed in **Attachment A**. The full year revised budget for 2019/20 as at the December quarterly review is a surplus of \$4.1m.
- The net funds generated as at the end of March 2020 is a surplus of \$11.5m (after capital revenues, expenditure and loan principal repayments). This is a positive variance to the YTD budgeted position of \$0.5m. This is primarily due to a timing variance in the delivery of CN's works program with a higher amount of project expenditure (both capital and operational expenditures) expected to be incurred during the final quarter of the financial year.
- 4 CN's temporary surplus funds are invested consistent with CN's Investment Policy, Investment Strategy, the Act and Regulations. Details of all CN funds invested under s.625 of the Act are provided in the Investment Policy and Strategy Compliance Report (section 4 of **Attachment A**).

The financial results contained in this report have been affected by economic factors from the COVID-19 outbreak. CN has experienced lower than anticipated revenues while also planning additional expenditure to address community needs. These trends are evident in the YTD reporting and are likely to worsen over the final quarter of the financial year. The financial impact of COVID-19 will be quantified and reported to Council in the March Quarterly Budget Review Statement in May 2020.

FINANCIAL IMPACT

The variance between YTD budget and YTD actual results at the end of March 2020 is provided in the Executive Monthly Performance Report.

COMMUNITY STRATEGIC PLAN ALIGNMENT

PURPOSE

The following Notice of Motion was received on 21 April 2020 from the abovenamed Councillor.

MOTION

That the City of Newcastle:

- Writes to Premier Gladys Berejiklian, Treasurer Dominic Perrottet the Minister for Planning Rob Stokes MP to:
 - a) Express its opposition to the recent changes to the Environmental Planning and Assessment Act which grant the Minister unprecedented powers to override planning decisions made by local councils, Planning Panels, the Independent Planning Commission;
 - b) Noting the Minister's Order allowing extended building and demolition work on weekends and public holidays, request the NSW Government provide extra funding for local Councils to monitor building sites during the extended working hours to monitor the observance of social distancing, as well as the noise emitted from these sites on the weekend, and;
 - c) Request further detail and full disclosure regarding the proposed changes outlined in the Media Release from Treasurer Perrottet and Minister Stokes on 3rd April 2020, such as fast-tracking State Significant Developments and greater Ministerial discretion.
- 2 Reaffirms its commitment to transparency and open governance, acknowledging that:
 - a) planning decisions should be community led and that local councils are best placed to make decisions about planning that is appropriate for their local area and constituents;
 - b) planning decisions have long term implications and even in times of crisis, planning approvals should consider the impact of development on the environment, local communities or neighbouring residents;
 - c) existing oversight powers are in place to ensure best possible planning outcomes; and

d) the extension of permissible construction hours has the potential to severely disrupt compulsory work and learn from home arrangements, and public health and wellbeing generally.

BACKGROUND

The State Government has amended section 10.17 of the Environmental Planning and Assessment Act (EPA Act) to give the government unprecedented powers to override planning decisions during the COVID 19 pandemic for at least the next 6 to 12 months.

Under the legislation, the NSW Planning Minister can authorise development to be carried out on land without the need for any approval under the Act or consent from any person.

Orders made by the NSW Planning Minister will have effect regardless of any environmental planning instrument or development consent.

This means that decisions made by local councils or regional planning panels can be overruled by the Planning Minister for any reason or no reason at all. These approvals cannot be reversed when the pandemic is over.

The NSW Treasurer and Minister for Planning issued a media release on 3 April 2020 foreshadowing further changes to the *Environment Planning and Assessment Act* 1979 in order to fast-track development.

This report has been classified confidential in accordance with the provisions of the *Local Government Act 1993* (Act) as follows:

- Section 10A(2)(d) of the Act provides that Council can close a meeting to consider commercial information of a confidential nature that would if disclosed prejudice the commercial position of the person who supplied it.
- Section 10B(1)(a) and (b) of the Act provides that the discussion of the item in a closed meeting must only:
 - (a) include as much of the discussion as is necessary to preserve the relevant confidentiality, privilege or security; and
 - (b) occur if the Council is satisfied that discussion of the matter in an open meeting would, on balance, be contrary to the public interest.

GROUNDS FOR CLOSING PART OF THE MEETING

In respect to section 10D(2) of the Act, the grounds on which part of a meeting is to be closed for the discussion of the particular item must be stated in the decision to close that part of the meeting and must be recorded in the minutes of the meeting. Accordingly, an appropriate resolution to proceed is required first.

MOTION TO PROCEED

The discussion of the confidential report take place in a closed session, with the press and public excluded, for the following reasons:

- A The matter relates to tenders for the Organics Processing Facility Design and Construction Contract 2019/144T.
- B It is contrary to the public interest to discuss tenders in an open meeting because the information provided to Council by tenderers is provided on the basis that it will be treated by Council as commercial-in-confidence. A practice of disclosing sensitive commercial information to the public, including competitors, could result in the withholding of such information by tenderers.

This would lead to a reduction in the supply of information relevant to Council's decision. A disclosure of confidential information by Council could result in Council being the subject of litigation for breach of confidence.
