# **PURPOSE**

To approve the process for the appointment of City of Newcastle (CN) alternate representatives to the Hunter and Central Coast Regional Planning Panel when required.

# RECOMMENDATION

# That Council:

Authorises City of Newcastle's Chief Executive Officer in consultation with the Lord Mayor and Councillor representatives to the Hunter and Central Coast Regional Planning Panel (HCCRPP) to determine staff or independent alternative representatives to the HCCRPP when Councillor appointed representatives or alternative representatives have declared a conflict of interest or conflict of duties or where they are otherwise unavailable to represent CN on the HCCRPP.

# **KEY ISSUES**

- The HCCRPP Secretariat at the Department of Planning, Industry and Environment has provided advice that CN can appoint two (2) alternate representatives to represent CN on the HCCRPP on occasions where Councillor appointed representatives or alternative representatives have declared a conflict of interest or conflict of duties or where they are otherwise unavailable to sit.
- 3 CN's Chief Executive Officer and Councillor representatives to the HCCRPP would be required to ensure staff or independent alternative representatives are suitably qualified or otherwise meet the requirements of the HCCRPP Secretariat.

# FINANCIAL IMPACT

There will be a minor cost from time to time to appoint a suitably qualified planning expert, which will be met from within approved relevant budgets.
