City of Newcastle is proposing the following traffic or parking amendment:

It is proposed to install "4P (9am-5pm Mon-Sun) on the northern side of Barclay Street Mayfield, between Rawson Street and Roe Street.

The proposed changes are in response to a request from a local resident to improve parking availability at the location.

Currently there is unrestricted parking on both sides of Barclay Street. Observations have indicated that on-street parking in the area is frequently occupied by long-term parking, impacting the ability to access available parking in the area.

CN, at any one time in all locations across the city, targets an 85% occupancy rate. That is, motorists seeking parking should find one parking opportunity for every 7 spaces checked. Currently the parking rate in this area often exceeds this level of occupation.

This proposal will allow a higher rate of parking turnover, improving access to parking in the area.

It is noted that most residents in Barclay Street possess two or more off-street parking spaces. As such "Residential Parking Permit" scheme cannot be applied to Barclay Street. Any parking restrictions installed will apply to all legally parked vehicles, this includes resident vehicles.

Submissions

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed traffic or parking amendment. The submissions must specify:

- the reference number TR2023/00961,
- the submitter's name, residential address, contact number; and preferably an email address, and
- whether the submission is in support or objection of the proposal.

Submissions must be made in writing and should be lodged via the online submission form on City of Newcastle's website.

Alternatively, submissions can be made by mailed to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.

All submissions received are considered 'Open Access Information' under the Government Information (Public Access) Act 2009 (GIPA) and therefore may be made available to the public.

Following the closure of the submission period, the proposal and submissions received will be considered by the Newcastle City Traffic Committee at an upcoming meeting.
